

Investment Objective

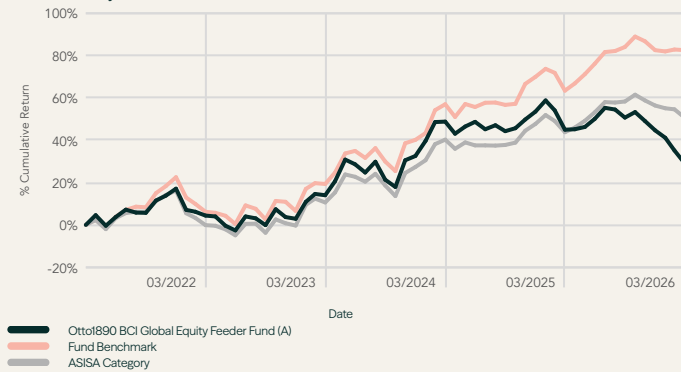
The Otto1890 BCI Global Equity Feeder Fund aims to achieve an attractive risk adjusted total return over a long-term investment horizon in USD terms.

Investment Approach

The portfolio will apart from assets in liquid form, invest solely in the participatory interests of the Otto1890 Global Equity Fund, established under Otto1890 Wealth SICAV, domiciled in Luxembourg. The underlying portfolio invests primarily in global equity securities, property related securities, non-equity securities, money market and other interest-bearing instruments, assets in liquid form, financial instruments as well as participatory interests of underlying portfolios of collective investment schemes or other similar schemes with similar objectives. At least 66.7% of the underlying portfolio's assets will be invested in equity securities.
